1. The Government of Nepal [GoN] *has allocated funds* from [GoN] towards the cost of **Barbardiya Municipality Office Of the Municipal Executive Jaynagar, Bardiya** and intends to apply part of the funds to cover eligible payments under the Contract *for Construction of Black top Road at Bhim Marga*.
2. Bidding is open to all eligible as per Section V of bidding document.
3. **Barbardiya Municipality Office Of the Municipal Executive, Jaynagar, Bardiya** invites electronic bids from eligible bidders for the *Construction of Black top Road at Bhim Marga* under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years:
NRs 3,56,00,000/-
 - Minimum Work experience of similar size and nature: at least 1(one) Contracts *and value of project NRs1,90,00,000/-*
4. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
5. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Barbardiya Municipality Office Of the Municipal Executive, Jaynagar, Bardiya** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
6. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e- submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document Fee (NRs.5,000/-) in the Project's Rajaswa (revenue) account as specified below.

7. Pre-bid meeting shall be held at Barbardiya Municipality at 14:00 on **24th October 2021**
8. Electronic bids must be submitted to the office **Barbardiya Municipality Office Of the Municipal Executive, Jaynagar, Bardiya** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 on 2nd November 2021**. Bids received after this deadline will be rejected.
9. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 on 2nd November 2021** at the office of **Barbardiya Municipality Office Of the Municipal Executive, Jaynagar, Bardiya**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs.6,75,000/-** which shall be valid for 30 days beyond the validity period of the bid (**120 Days**)
10. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
